Levels of Coverage

• Elite Coverage

Top level coverage similar to the manufacturer's comprehensive warranty. All components are covered other than a select list of exclusions.

• Plus Coverage

Coverage above and beyond the powertrain to include many critical vehicle components that are costly to repair.

• **Basic Coverage** Solid protection for major powertrain components.

Discounted 'Wrap' Pricing

Elite and Plus Coverage pricing is discounted when combined with the manufacturer's powertrain warranty.

Multi-Media Software Package (optional upgrade)

This package covers the cost of all manufacturer's recommended software upgrades for the vehicle's entertainment and navigation systems (up to \$500).

Deductible Options

- \$0 Deductible (not available on limited liability plans)
- \$50 Deductible
- \$100 Deductible *
- \$250 Deductible *

*Dealer Loyalty Deductible: When the customer returns to the selling dealer, their deductible is reduced by \$50. Note this is available on \$100 and \$250 deductibles.

Eligibility

- New vehicles with at least 1 day and 1 kilometre of manufacturer's powertrain warranty remaining at time of contract/policy purchase
- Used vehicles within 13 model years and 160,000 kms at time of contract/policy purchase
- Certified Pre-owned vehicles with a minimum of 1 day and 1 kilometre of CPO coverage remaining from the original manufacturer at time of contract/policy purchase

Terms

- New vehicles are eligible for terms of up to 10 years and 200,000 kms from in service date.
- Used vehicles and Certified-Pre-Owned vehicles are eligible for terms of up to 4 years and 80,000 kms from the contract/policy purchase date.

Additional Benefits

24 Hour Roadside Assistance

Each MBP contract/policy comes with 24 Hour Roadside Assistance for the term your customer purchased, including the following benefits:

- Towing
- Battery Jump Starting
- Tire Change (using spare tire)
- Fuel Delivery
- Lockout Service
- Winching
- Concierge Service

Trip Interruption

In the event a covered breakdown occurs more than 150 kms from your customer's home and results in a repair facility keeping their vehicle overnight, receipted motel and restaurant expenses will be covered up to \$100 per day including taxes, up to a maximum of four days (\$400).

Rental Benefits

MBP will pay or reimburse your customer \$50 per day (up to 4 days, for each 8 labour hours) for the expense of a rental vehicle while their vehicle is being repaired for a covered breakdown. An additional 3 days rental will be provided in the event of an engine or transmission parts delay. *Note this benefit is not available on Basic plans.

Claim-Free Reward (available on select Elite and Plus Plans only)

If your customer doesn't claim any benefits during their SecureDrive coverage term, they may be eligible for one of the following Claim-Free Rewards:

- Coupon in the amount of the total value of the contract purchased for a new SecureDrive MBP contract; or
- Issuing dealer store credit of up to \$2,000; or
- Refund cheque of up to \$1,000

Other Features

- If the vehicle is sold, the MBP contract/policy is transferable to the next private owner
- Customers are eligible for a full refund if they wish to cancel the contract/policy within 30 days from the purchase date
- MBP contracts/policies are eligible for financing through the No Interest Deferred Payment Plan
