Step 3 of 3: Select Product Options

Indicate here if the vehicle is Certified Pre-Owned (5).

The OEM Parts (6) option allows the contract to only use OEM replacement parts, this options is available for non branded contracts only.

The **Additional Benefits** (7) option allows the contract to be sold by adding additional coverages to the contract, clicking on **Details** (8) describes available additonal coverages.

Those additional coverage could also include the **Claim Free Reward Benefit**, which provides the customer with a reward if no claim is made during the lifetime of the contract. To be eligible for the **Claim Free Reward Benefit**, the following conditions must be met:

- 1. The contract must expire by time only; and
- 2. The difference between term expiry date and contract date is at least three years; and
- 3. The difference between the expiry km and current odometer reading is at least 40,000 km.

Details about the Claim Free Reward Benefit can be found in the Selling Dealer Guide which can be downloaded from Sales Tools.

Some contract also have **Tire Storage** as an optional upgrade.

Verify the Contract Date (9) and specify a Lienholder (10) if applicable.

Enter a dollar amount in P-Code (11) to offer your customer a discount. Hover over the Retail Price (12) to view your dealer markup.

Chose the Selling FSM (13) from the drop down menu.

Once the desired product options have been selected, ensure customer details are entered and click Purchase (14).

Confirm purchase and print out the contract for the customer to sign.
